This list does not include prices for certain items that you may ask us to buy for you, such as cemetery, flowers and newspaper notices. The prices for these items will be shown on your bill or the statement describing the funeral goods and services you selected. The funeral home may receive bulk discounts for such items. Said discounts will be retained by the funeral home. Certain funeral services may be provided off premises by other funeral service providers. The following package prices and the normal operating procedures of Cremation Choice are for arrangements to be made nline or over the phone, however if you desire an in-person consulatation the fee for that is explained in this price list.

Cremation Packages

(Each of these packages includes an alternative container for the cremation process and a temporary container for the cremated remains,the crematory fee and the medical examiner fee. The packages do not include certified copies of the death certificate or applicable sales tax.)

Simple Dignified Cremation:

Just the basics, No extras- everything you need to provide for the cremation process in the most cost effective manner.

This package includes:

Basic services of licensed professional and staff, transfer from place of death (35 mile radius), basic care of deceased, use of refrigeration (for up to 10 days), filing any additional necessary paperwork, cremation fee, medical examiner fee, tray case alternative container and temporary container for cremated remains.

Cemetery Graveside Service:

Simple cremation and arrangement for a dignified committal service for the cremated remains.

This package includes:

Basic services of licensed professional and staff, transfer from place of death (35 mile radius), basic care of deceased, use of refrigeration (for up to 10 days), filing any additional necessary paperwork, cremation fee, medical examiner fee, tray case alternative container and temporary container for cremated remains, coordination with local cemetery for committal service, delivery of cremated remains to cemetery (35 mile radius), use of equipment and staff for cemetery committal service.

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff that is available 24 hours a day to respond to initial request for service; online arrangement conference with family and responsible parties; preparation and filing of necessary authorizations and permits; recording vital statistics; and coordination with those providing other portions of the funeral, e.g., crematory and others as required. Also included in this charge are overhead expenses relative to our facilities such as sheltering of remains, professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping, and secretarial and administrative expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Our charges (without funeral ceremony or facilities for viewing) include transfer of remains into our care, basic services of funeral director and staff, basic care, identification of the remains, crematory's fee and the Medical Examiner's fee (\$100.00 required by Virginia statute), and hand delivery of the cremated remains (within a 35 mile radius). The certified copies of the death certificate (\$12 ea.) and applicable sales tax (6% on merchandise) will be added to the funeral home's charges for the service selected.

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are: cardboard or composite wood containers. The minimum of an alternative container is required by the crematory and Virginia statute.
